

IIANC Education Foundation Scholarship

Any Independent Insurance Agency that is a member of IIANC and has licensed agents in their office may apply for this \$5,000 scholarship.

The \$5,000 that is awarded must be used towards the education of the personnel in the agency and must be used within one calendar year.

Many factors will be taken into consideration in the awarding of the scholarship to an Agency. Included in these factors are:

- 1) Participation of staff in IIANC Events
- 2) Participation of staff in IIANC CE classes
- 3) Participation of staff in other CE not through IIANC
- 4) How the Agency supports the Continuing Education of their staff
- 5) The need of the Agency for the scholarship money to execute a plan to further the education of their staff

The Education Committee for the IIANC will evaluate each application. The winner of the scholarship will be announced at Annual Convention in October.

IMPORTANT NOTE: An agency which has received the scholarship within the previous 5 years is not eligible to apply
